**LOCAL SCHOOL BOARD ORDINANCE NO. 1**

AN ORDINANCE APPROVING THE PROGRAM OF APPROPRIATION UNDER THE SPECIAL EDUCATION FUND OF THE MUNICIPALITY OF CARDONA FOR FISCAL YEAR 2013.

Be it enacted by the Local School Board of Cardona in Council assembled.

**Section 1. SOURCE OF FUNDS.** The following income as indicated hereof is hereby declared as Source of Fund of the Special Education Fund for Fiscal Year 2013 certified by the Municipal Treasurer as realistic and probable to be collected necessary to finance the implementation of priority education programs and projects of Public Schools in the Municipality of Cardona from January 1 to December 31, 2013.




